

Recruitment announcement - General Manager for Complexul Energetic Hunedoara S.A.

The Company **Complexul Energetic Hunedoara S.A.** has resulted on 01.08.2013, from the merger by absorption between S.C. Complexul Energetic Hunedoara S.A. – established on 01.11.2012, as a result of the merger by acquisition process of S.C. Electrocentrale Deva S.A. and S.C. Electrocentrale Paroseni S.A, according to the provisions of the Government's Decision no. 1023/2011 regarding some reorganisation measures for the electric energy producers, under the authority of the Minister of Economy, Commerce and Business Environment, as absorbing company and Societatea Națională a Huilei S. A. Petroșani as absorbed company, according to the provisions of art. 238, paragraph (1), letter a) of the Companies Law no. 31/1990 amended and supplemented, and according to the Merger Agreement published in the Romanian Official Gazette, part IV, no. 2722/24.05.2013.

The sole shareholder of the Company is the Romanian State, represented by the Ministry of Economy - Energy Department, the Company's management structure is Unitary.

The company performs the following activities:

- exploitation of the coal deposits in Jiului Valley;

- production, supply and trade of coal based electric energy;

- production, dispatching, transportation, distribution and supply of thermal energy;

- geological research for the discovery of coal deposits;

- maintenance, in order to operate in an integrated manner and become one of the main players in the region, by capitalizing with maximum efficiency the potential Romania has in the field.

According to the Government's Emergency Ordinance 109/2011, The Company Complexul Energetic Hunedoara S.A. has selected S.C. Quest Advisors S.R.L to assist it in the selection process for the job General Manager.
